finished products before they leave the facility. It's guaranteed that each of our high-quality formulas are 100% compliant with the ingredients listed on the label, meet, or exceed cGMP quality standards, and undergo rigorous testing. Good Manufacturing Practices (cGMPs) guarantee that our formulas meet strict requirements for product quality, as defined by the U.S. Food and Drug Administration. The cost of my nutrients is right in line with what nutrients are right in line with what nutrients cost. If they're slightly more expensive it's because it's a better-quality product, better bioavailability, and produces results. Many of the products use a soft gel capsule for convenient consumption and digestion. I don't use tablets because they are very hard for the body to absorb.

When I give you a nutrient it is typically a formulation which means the nutrient is a combination of formulas for a variety of reasons. What does this mean? For instance, if I find that you're dropping into hypoglycemia (low blood sugar) I may give you a nutrient that contains six or seven different vitamins, minerals, herbs, enzymes, etc. Whatever may be in that formulation has been shown in the scientific literature to support hypoglycemia. These nutrients are all science-evidence based which means that the ingredient has been proven to support those specific mechanisms, in this case it's hypoglycemia. I then take those different ingredients and combine them to create a formulation. Now you have all the best products that are science-evidence based to create the best possible results.

The products are also always being updated. If we find that there's another product that has been shown to help with something specific, in this case sticking with hypoglycemia, my nutrient will also change to include that.

Vitamins and minerals do not need to be approved by the FDA because they are **naturally occur**ring in our environment and bodies. They do not pose any negative side effects to the user. The FDA approvals are on drugs. A vitamin or mineral becomes a drug when its DNA becomes altered, chemically changing it to something that is not naturally occurring. Roughly 1/3 of all FDA approved drugs will be removed from the market. This means that after studies are done the drug is released to the public but generates a substantial amount of side effects/death resulting in the drug being pulled off the market. Drugs are also considered GMO because they have been chemically modified causing them to generate side effects and pose danger to the users. Vitamins and minerals are non-GMO. They also cannot be patented because they are naturally occurring.

The products that I provide here are all based on science. I give you products based on what your blood work shows that you need to restore the different mechanisms of action. The supplements are aimed at lowering your allostatic stress load and raising your healABILITY by allowing the power that made the body heals the body.
